#### **MEETING MINUTES**

#### 1. CALL TO ORDER & INTRODUCTIONS

Nic Stark called the meeting to order at 6:02 PM.

#### 2. ADOPTION OF UPDATED BYLAWS

Following discussion of new Open Meeting Law Amendment Council was named explicitly as an advisory council. Motion Made by Frank Nelson, seconded by Dwayne Daigle, none opposed. Motion passed.

#### 3. APPOINTMENT OF OFFICERS

# 4. UPDATES FROM STATE, MUNICIPAL, AND CHAMBER MEMBERS

Granville: Dwayne met with lawyer for snowmobile association, they will set up a lawyer with NYS

Parks and Rec, and local representatives to discuss alternative routes for the missing link.

Castleton: Gravel donated by Hadeka Stone to trailhead area by Castleton University, more will be needed before new kiosk is installed.

Pawlet: Work continues determining use of remaining funds in Pawlet/Rupert VOREC grant funds, Jim Henderson will continue with development of a new parking area in Rupert.

#### 5. MISSING LINK

Nic offers to produce a timeline of the development of the rail trial for the benefit of the Council. The timeline will include any and all items related to the legal complications concerning the missing link.

### 6. OTHER BUSINESS

Jim Henderson brings up that the mile markers along the rail trail are incorrectly placed. It is agreed that this will be an item to revisit at the next meeting and during the development of the management plan. There is also the southern most section of the trail that crosses over into NYS that appear to be unmaintained

Nic will be compiling a preliminary list of businesses that could apply for the Trail-Friendly Business Program for review by the Council.

Nic shares the tool he is building for collecting the points of interest across the municipalities for the new interactive map that will live on the rail trail website. It is agreed that for the first iteration of the



POI submission we should focus on essential assets that are within close proximity of the rail trail with the idea of expanding outward in future updates.

Nic lets the Council know that the meeting next month will take place at the new Rutland Regional Planning Office, details will be included in the invitation.
