#### **MEETING MINUTES**

- 1. CALL TO ORDER & INTRODUCTIONS Frank Nelson called the meeting to order at 6:13 PM
- APPROVAL OF JULY 10 DRAFT MEETING MINUTES Jim Henderson makes a motion to accept the draft minutes, Philip Wattenbarger seconds, ayes have it.

#### 3. UPDATES FROM STATE, MUNICIPAL, AND CHAMBER MEMBERS

Castleton: No member present.

**Pawlet:** Seeing heavy trail usage, mainly bikers.

**Poultney:** Sarah Pelkey asked for the issue of dog waste and trash between Church and Main Street to be brought up. Nic to bring up to RPC Rail Trails Group to ask for ideas and see how other trails deal with the issue.

Granville: No member present.

**Rupert:** John La Vecchia met with Jackie Cassino, Bill Gray, Jim Henderson, and Tom Wilson about Rupert Parking Lot. Jim Henderson provided a quote for the construction parking lot from 2 years ago that he believes will serve as a good ballpark figure. Nic Stark, Jim Henderson and Jessica Van Oort to meet Friday to discuss the VOREC grant budget for the parking lot and W. Pawlet Amenities.

# 4. TRAIL USAGE DATA COLLECTION DISCUSSION
