# CALL TO ORDER & INTRODUCTIONS Matt Brown called the meeting to order at 6 PM

# 2. APPROVAL OF PREVIOUS MEETING'S DRAFT MEETING MINUTES Frank Nelson makes a motion to accept the draft minutes, Dwayne Daigle seconds, ayes have it.

### 3. UPDATES FROM STATE, MUNICIPAL, AND CHAMBER MEMBERS

**Castleton:** Castleton University has cleared a section of land that abuts the Rail Trail right of way. **Pawlet:** W. Pawlet Vermont Outdoor Recreation Economic Collaborative Grant – Site Visit to place amenities took place. Jessica Van Oort is leading the project. Still questions about ownership of the old freight building.

**Poultney:** Nic Stark talked about reporting tool from VTrans, will send out via the mailing list. Matt Brown suggested a QR code sign linking to the reporting tool be added to kiosks. Phillip Wattenbarger reported that the old D&H Depot building has been sold and will be developed into a new restaurant.

Granville: No updates.

**Rupert:** Jim Henderson did get sign specs from VTRANS and will get updated sign estimates. Hoping to have quotes in the next week or so for the parking area and others. Adjacent property owner wants the prospective parking lot moved to other side of the road form where it was staked out.

### 4. ETHAN PEPIN: ASH TREE INVENTORY

Ethan presented on the Emerald Ash Borer infestation and the data collected by an RRPC intern. Tom Clark brought up issues with non-native cherry trees. Ethan explained that the state of Vermont has started developing hazard mitigation planning around the infestation. There are 582 ash trees between Castleton and Poultney.

#### 5. TRAIL USAGE DATA COLLECTION DISCUSSION

Nic Stark reported that neither VAST nor SVT had counters or capacity to conduct counts on the DHRT. Dwayne Daigle makes a motion to implement the counter plan presented to the council last month to begin in October, Philip Wattenbarger seconds, ayes have it.

#### 7. OTHER BUSINESS

Nic Stark announces he's meeting with the consultant hired by VTrans to develop the Rail Trail Management Plan at end of the week.

A rep from Local Motion (a VT bike/ped advocacy group) will present at the next meeting on the Western New England Greenway Project.

Frank brings up the need for public restrooms on the trail.

#### 8. PUBLIC COMMENTS AND CONCERNS

Tom Clark posited that the flooding in Salem is what ended the viability of the rail line. He shared photos he took of previous flooding events and explained that the White Creek in W. Rupert is going to continue to cause issues. Nic Stark to investigate UVM flooding simulation software. The council will look into putting flood mitigation into the upcoming rail trail management plan.
