4. UPDATES FROM STATE, MUNICIPAL, AND CHAMBER MEMBERS

Castleton: Everything is in good shape.

Pawlet: Lots of usage based on Frank's observations.

Granville: Dwayne Daigle had a meeting with a State Senator and is hoping to meet with them again on the Missing Link issue.

Rupert: Progress on development of Cross Road Parking Lot. Highway crew eager to get started on 6-car 30x60' lot. Jim Henderson got 3 quotes for signage, going with lowest bidder as all were identical.

5. TRAIL USAGE DATA COLLECTION UPDATE

Nic Stark informed the council that due to timings issues the trail usage data wouldn't make sense to begin until the start of the peak season in 2025 to collect a full cycle. The council agreed.

6. MISSING LINK UPDATE

No updates beyond what Dwayne Daigle reported in his municipal update.

7. OTHER BUSINESS

Frank Nelson proposed the possibility of lowering the trail where flooding issues were identified, Bill Gray noted that approach had not worked on the LVRT.

Following up on discussion from last month Nic reported that there was no usable flood simulation tool produced by UVM that the council could use.
