Meeting Minutes for

Wednesday, March 19, 2025 – 5:30 pm

Rutland Regional Planning Commission – Microsoft Teams

I. Voting Member Roll Call

Chair Michael Jones convened the meeting at 5:30 PM. Maggie O'Brien conducted the voting member roll call. A quorum of voting members was present.

II. Approve Meeting Agenda

Judy Frazier made the motion to approve the March 19, 2025 Agenda. Motion seconded by Bob Morlino. No further discussion. Motion approved.

III. Approve September 18, 2024 Meeting Minutes

Morlino made the motion to approve the September 18, 2024 Meeting Minutes. Motion seconded by Bob Case. No further discussion. Motion approved.

IV. Open to the Public

There was no one from the public in attendance.

V. REMC Representative Reports

- a. Statewide Local Emergency Planning Commission (LEPC) Rep, Bob Morlino
 - i. Morlino presented on the origin of the State LEPC, its purpose and function, and an overview of State HazMat activities in 2024. The State Emergency Response Committee (SERC) recently contacted every facility in the state that uses extremely hazardous substances, notifying them of the mandate (through the Emergency Planning and Community Right-to-know Act) to have representatives on the LEPC. The next LEPC meeting is April 8, and Morlino expects hundreds of attendees as a result of this outreach.
- b. Threat Hazard Identification & Assessment/Stakeholders Preparedness Report (THIRA/SPR) Rep, Peter Mantello
 - i. Mantello was not present. O'Brien stated there was nothing new to report.
- c. Integrated Planning and Preparedness Workshop (IPPW) Rep, Tom Johnston
 - i. Johnston was not present. O'Brien updated the Committee that the workshop now occurs over one session instead of two and has a tighter focus on closing gaps in high priority core capabilities in the 2024 Stakeholder Preparedness Review (Public Information and Warning, Mass Care Services, Cybersecurity, Operational Communications). The 2025 workshop is scheduled for June 16, and a report will be provided at the next REMC meeting.

VI. REMC Organizational Tasks

There were no outstanding organizational tasks.

VII. Announcements/Roundtable

- a. Southern Region Recovery Model FEMA: O'Brien briefed the Committee about ongoing efforts to establish regional "recovery networks" in Southern Vermont. The change in the Federal administration is putting funding for Regional Recovery Officers and other efforts into question. At the meeting on March 17, Regional Councils were proposed as a means of informal county governance. The region recovery models are now being envisioned as a short-term (five to ten year) supportive measure until county government can be established in Vermont.
- b. Schedule of Emergency Management Activities: The final calendar of activities from October 2024 to September 2025 is ready for distribution. They will be shared with the Committee alongside the March 19, 2025 draft minutes. Upcoming events include a LEMP 2025 Seminar on April 16, a Local-Liaison re-training session on May 21, and a Local Liaison drill conducted by the State in June on an unknown date.
- c. Binary Blizzard Update: The full-scale exercise is still slated for October 2025. Given an increasing focus on building a regional emergency management support network, O'Brien reported the Binary Blizzard Buildup (B3) efforts would be winding down, though Towns are still encouraged to participate if they would like. Morlino and Chair Jones stated that Pawlet and Castleton would still be participating in the exercise, including the activation of an Emergency Operations Center (EOC). O'Brien recalled some other Towns previously expressing interest (Brandon and Mount Holly) and will circle back with their EMDs to confirm.
- d. Regional Emergency Management Needs Assessment: Eric Pulver and O'Brien informed the committee members of collaboration efforts to date between the REMC and the Rutland Regional Disaster Cooperative (RRDC). The current focus is developing a baseline understanding of municipal needs in the Region during the planning, response, and recovery phases of emergency management. Pulver proposed the idea of a series of "subregional" mini tabletop exercises to evaluate items such as food and water security, shelter and EOC operations, and identifying communication and recovery needs. An extensive discussion was held regarding the organization of the sub-regions based on local relationships and procuring buy-in through local outreach and meetings led by "community champion" towns. The Committee expressed a willingness to proceed with this approach, and the first exercise will be held for the north-east region (Brandon, Chittenden, Killington, Mendon, Pittsford, and Sudbury) before the end of June.
